## **ISSUES & IMPACT**

### Sean P. McIlmail Institute of Statute of Limitations Reform



CHILD USA tracks state and federal SOL reform and updates the SOL Tracker every week. The Legal team also produces an annual report documenting the history of SOL Reform since 2002. In 2022, CHILD USA submitted testimony 32 times before state and federal governments, one-third of which involved SOL reform. Through the Amicus Advocacy Project, CHILD USA moved child protection forward in the courts and submitted 26 amicus briefs in 2022.

### **Global SOL Reform Task Force**



The Global SOL Task Force is a joint project by CHILD USA and the BRAVE Movement that extends CHILD USA's groundbreaking success in SOL Reform in the U.S. to the globe. CHILD USA is leading the effort to establish a global dashboard with the CSA SOLs for every country in the world. We started with North, Central, and South America and will pivot to Europe in 2023.

### **Elite Athlete Study**



CHILD USA is proud to lead the way in athlete abuse research in the United States. We published the first in a series of peer-reviewed articles on the results of our Elite Athlete Study. The article "Child Sexual Abuse of Elite Athletes: Prevalence, Perceptions, and Mental Health," published in the Journal of Child Sexual Abuse, provides unique, original data on the prevalence of CSA in athlete populations in the United States. Upcoming articles will explore other types of maltreatment and how those traumatic experiences connect to later mental health outcomes.



#### **The Game Over Commission Report**

CHILD USA led the Game Over Commission to Protect Youth Athletes, which published its Final Report, in January 2022. This groundbreaking Report, based on a case study of serial abuse perpetrated by Larry Nassar, showed that reforms are needed across elite athletics, law enforcement, and the legal system to ensure that there is a safety net and reporting structure in place for athletes who face abuse.



## **ISSUES & IMPAC**



### **Federal Legislation**

CHILD USA has been making considerable strides in advancing the civil rights of children through advocating for federal legislation since 2016. In 2022, CHILD USA, together with its sister organization, CHILD USAdvocacy, worked with federal lawmakers to draft and enact laws that will better protect children throughout the country.

• Eliminating Limits to Justice for Child Sex Abuse Victims Act of 2022

CHILD USA played an integral role in the successful passage of Federal legislation that eliminates the civil statute of limitation for over a dozen federal child sex abuse-related offenses, including sex trafficking of children, sexual abuse of a minor, and sexual exploitation of children. Now victims of these heinous crimes will be able to come forward when they are ready.

#### • Bankruptcy Law Reform

CHILD USA led the way in 2022 with a groundbreaking proposal to make federal Bankruptcy law safer and more effective for child victims. <u>The Norton Journal for Bankruptcy Law and Practice</u> published our social science and legal insights into the problem in two articles. Overall, the reforms CHILD USA is advocating for in the bankruptcy system would provide victims with a voice and more influence in holding the institutions that allowed their abuse accountable.

#### • Title IX





CHILD USA's Legal Department engages in meticulous research and analysis through which they were able to identify the shortcomings in the existing Title IX framework and the urgent need for legislative change. In 2022, the Legal Department served as a resource and partner for federal lawmakers in the fight to amend Title IX to ensure equal access to justice for all victims of sexual assault, regardless of geographic borders. Additionally, in 2022, the legal team provided amicus support on two groundbreaking Title IX cases against Ohio State University for their role in covering-up decades of abuse by denounced university physician Richard Strauss. Our expertise and research enabled us to educate the courts about the functional and systemic obstacles that victims face when seeking to hold their schools accountable for enabling abuse.

## **ISSUES & IMPACT**





#### Online Exploitation & Abuse

CHILD USA's Legal Department works tirelessly to educate state and federal lawmakers and the public about the dangers of online child exploitation and abuse and the pressing need for legislative action to protect victims by holding service providers accountable for facilitating the spread of child sexual abuse materials (CSAM) on their platforms. CHILD USA consulted on and endorsed several successful bills aimed at increasing penalties for CSAM offenses and expanding the crimes subject to criminal or civil liability at the federal level. Our Legal Team also testified on the EARN IT Act and provided amicus support on cases against some of the biggest names in tech, including Omegle, Twitter, Reddit, and, most recently, Google in the case Gonzalez v. Google before the United States Supreme Court.

#### Preventing Educator Sexual Misconduct





Our Social Science team partnered with researchers at Virginia Commonwealth University and the Center for Disease Control and Prevention to implement a four-year study on CSA prevention in schools. The innovative project will provide much-needed evidence on the effectiveness of prevention training. We conducted over 50 in-depth interviews with school administrators to understand challenges in prevention policy implementation at the K-12 level. Our upcoming conference presentations and publications will highlight best practices to keep kids safe in schools.



## **ISSUES & IMPACT**

### **Fact-Based Commentary and Education**



Founder and CEO Marci Hamilton is known and respected as a preeminent authority and educator in the field of statutes of limitation reform. A highly acclaimed lecturer and author, she maintains a schedule of speaking engagements, podcast guest appearances, and training workshops. Along with the Executive Team at CHILD USA, her work has profoundly influenced and informed policy decision-makers and the public through countless speaking and educational events, podcasts, and major market media.



Our researchers wrote multiple blog posts aimed at inserting facts and reason into the public debate about children's issues. From the controversy over "grooming" to the impact of the Dobbs decision on children who may become pregnant, CHILD USA jumped into the fray to make sure that children's best interests are always prioritized in our public discourse.



As pioneers and the only think tank to document, research, and analyze SOL reform for CSA victims, CHILD USA is committed to being a powerful and transformational force for systemic change. We will continue to educate and collaborate with child protection professionals and the public about science-based approaches to child and family policy.

## **JASON BERRY**

The 2022 recipient of the Sean P. McIlmail Hero Award, Jason Berry was reporting on child sex abuse in the Catholic Church in the 1980's, long before anyone wanted to hear about it.




