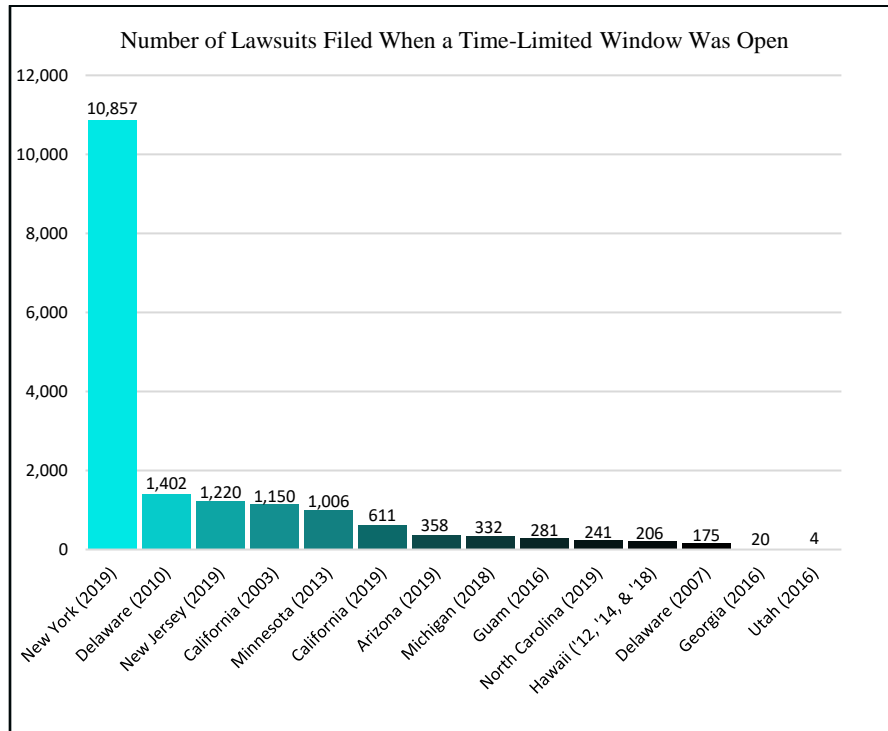


The Relative Success of State Windows for Child Sexual Abuse Claims

Summary: States opening revival windows for time-barred claims against all types of defendants have seen a modest and manageable number of lawsuits and brought long overdue justice to victims of child sexual abuse. Revival windows have exposed hidden predators and the institutions that enabled them, making their states safer for future children.
