- Meeting with Survivors and Advocates
- Creating United Fronts
- Writing op-eds

- Constant contact, availability, and follow-up
- Traveling to state capitols & testifying in-person
- Meeting with local press

Execute in steps and legislative sessions. May take a few sessions of educating and perhaps embarrassing or shaming lawmakers.




### **FAST BREAK**





<u>Alabama</u> - Extension to age 55 with revival & 2-year window (SB358)

<u>Georgia</u> - Extension to age 38 & 1-year window, 4-year discovery.

Kathryn testified March 8, 2021 (HB109)

Hawaii - Extension to age 50, 5-year discovery. Kathryn testified Feb. 23, 2022 (SB2208)

Iowa - Eliminate Civil SOL for some criminal wrongs. Kathryn testified Jan. 31, 2022 (SF 2095)

<u>Kansas</u> - Elimination with window (after July 1, 1984)

<u>Kentucky</u> - Elimination SOL. Kathryn testified on Feb. 17, 2022 (SB153 & HB 464)

Maine - Elimination of charitable immunity

<u>Massachusetts</u> - Elimination of SOL perps & institutions, permanent window & elimination of charitable immunity for CSA

<u>Michigan</u> - Talks are ongoing for this session - 2021 bill (HB 4306) <u>Missouri</u> - Talks ongoing with key stakeholders (political landscape a standstill)






